HOW IT WORKS

- Your money is invested in a managed investment fund (called Trend)

- National Australia Bank Limited (NAB) ABN 12 004 044 937 is the independent custodian that will hold the assets of the Trend

- Income distributions are reinvested into the Trend or you can elect for them for them to be paid once a year
- You will always know where your money is invested and receive annual tax statements to help complete your tax return
